

**Minutes of the Committee meeting on Short Term Tender for Providing 01 Cook and 15 Group-D employees through Outsourcing for the Abdul Nazir Sab State Institute of Rural Development, Mysuru for ONE Year - Financial Evaluation conducted on 11-03-2015 at 4.30 PM at Director Chamber at ANS SIRD, Mysuru.**

A Short Term Tender called through e-procurement for providing 01 Cook and 15 Group-D employees through Outsourcing for the Abdul Nazir Sab State Institute of Rural Development, Mysuru for a period of 12 months. Invitation of tender through e-procurement No:SIRD. EST /CR:89/2014-15 published in tender bulletin on 07-02-2015. Last date and time for receipt of tenders was 19-02-2015; 4.00 PM. A pre bid meeting was arranged on 11-02-2015 at 11.30 AM in ANSSIRD, campus, Mysore.

The technical bid was opened on 23.02.2015 at 1.30 PM in which a total of 04 bids were submitted through the e-portal. Out of the 04 bids only 03 agencies qualified in the technical bid. The financial bids of these agencies were opened on 05-03-2015.

**M/s Bharath Enterprises**, Near Govt Higher Primary School, 5<sup>th</sup> Cross, Halahalli, **Mandya**. quoted 1 % on the bid amount of Rs.15,81,216/- put to tender.

**M/s Canon Detective & Security Service**, # 1566, 9<sup>th</sup> Cross, 2<sup>nd</sup> Floor, Avalahalli Main Road, Muneswara Block, **Bengaluru – 26** quoted 1 % on the bid amount of Rs. 15,81,216/- put to tender.

**M/s Corporate & Industrial Security Force & Training Centre**, Anushri Complex, M.V. Nagar, BEML Nagar Post, **K.G.F. Bangarpete (Tq) – 563 115** quoted 2 % on the bid amount of Rs. 15,81,216/- put to tender.

**M/s Bharath Enterprises**, Near Govt Higher Primary School, 5<sup>th</sup> Cross, Halahalli, **Mandya** and **M/s Canon Detective & Security Service**, # 1566, 9<sup>th</sup> Cross, 2<sup>nd</sup> Floor, Avalahalli Main Road, Muneswara Block, **Bengaluru – 26** have both quoted one per cent of the amount put to tender. These two bids have quoted equal rates. There are no explicit Government Order or Rules as to how the decision has to be taken when two firms quote same rates on amount put to tender. The Tender document is taken from KG2 designed by Government of Karnataka has condition number 18(35) states – *“in case two or more bidders quote the same price, then the past experience and past track record of the agency will be considered for the award of the tender”*.

**M/s Bharath Enterprises, Mandya** has submitted experience certificate in proforma A under Sec XII to a tune of Rs.56.84 lakhs and its gross annual turnover for the year 2009-10 is 23.48 lakhs, 2010-11 is Rs.42.45 lakhs, 2011-12 is Rs.55.45 lakhs, 2012-13 is Rs.90.54 lakhs and 2013-14 is 56.48 lakhs.

**M/s Canon Detective & Security Service, Bengaluru** has submitted experience certificate in proforma A under Sec XII to a tune of Rs.108 lakhs and gross annual turnover for the year 2010-11 is Rs.6.47 Crores, 2011-12 is Rs.5.61 crores, 2012-13 is Rs.10.02 Crores and 2013-14 is Rs.10.41 crores.

As per Tender condition number 18 (35) M/s Canon Detective & Security Service, Bengaluru's experience and past track record is better than M/s Bharath Enterprises, Mandya. Hence the contract may be awarded to M/s Canon Detective & Security Service, Bengaluru for the quoted rate of 1 % against the amount put to tender.
