**Faculty Positions**

Out of the five candidates shortlisted for the posts of Core Faculty (Land and Water Resources), the following candidates appeared for the interview. Dr.Ramakrishna was absent for the interview.

Candidates were interviewed by the Selection Committee. The Selection Committee did not find any suitable/eligible candidates as the case may be for the posts of Faculty (Decentralisation). Selection Committee recommended calling for fresh Expression of Interest for the posts with revised conditions.

#### **Expert Faculty (Gulbarga)**

One candidate shortlisted Sri. Ramesh R.M. for the post of Expert Faculty (Decentralisation) did not attend the interview. Sri.
